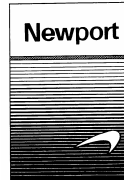

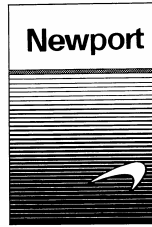

The Opponent opposes the above trademark Application on the grounds that:

1. the word "FLOVOR", which the Applicant seeks to protect as part of its mark, cannot be claimed exclusively by one single proprietor as it is commonly appropriated to all products within Class 34 of the International Classification of Goods and Services under the Nice Agreement, of which the Applicant presently seeks registration under (hereinafter referred to as "Tobacco Goods").
2. The word "FLAVOR" is inherently descriptive for such consumable products as tobacco goods. Since tobacco goods are primarily oral products which are gustatory and olfactory sensitive in nature, marketed primarily on the issue of taste, the use of the term "Flavor" within, upon or related to various marks of tobacco goods is naturally an obvious and regularly occurring one.
3. As a show of good faith, the Opponent would allow the registration of the Applicant's mark but respectfully requests that the "FLAVOR" word element of the Applicant's mark be subject to disclaimer ("Disclaimer") under Section 28 of the Trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000 including any amendments thereto and Rule 30 of the Trade Marks Rules thereof.
4. The Opponent requests the said disclaimer upon the Applicant's mark on the grounds that such a word element is not independently capable of being registered for tobacco goods under International Class 34 and so that if the mark is registered the public will understand the extent of the Applicant's rights after registration.
5. Should the applicant wish to retain its current Application without disclaimer, the Opponent respectfully requests that the subject Application for the Applicant's mark be refused registration..

The Applicant is required to submit a response to this notice, to the Registrar, no later than 30 days from the date of publication of this notice.
