NOTICE OF OPPOSITION

TAKE NOTICE that the Registrar is in receipt of a notice of opposition filed by British American Tobacco (Brands) Limited, against trademark Application No. 5754.08, filed on the 14th day of October, 2008, by Philip Morris Products S.A. (The Applicant), of Quai Jeanrenaud 3, 2000 Neuchâtel, Switzerland, for the registration of the following trademark, as proprietor thereof:








The Opponent opposes the above trademark Application on the grounds that:


1. The Applicant's Mark is devoid of any distinctive character and contravenes section 35 (1)(b) of the Trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000 and amendments thereto (hereinafter referred to as the "Trade Marks Act") and should not be registered by virtue of the fact that this is an absolute ground for refusal of registration by law;
2. It is the knowledge, information and belief of the Opponent that the Applicant's Mark has not acquired any distinctive character as a result of the use made of it and therefore the Applicant cannot aver any defence as to its contravention of the said 35 (1)(b) of the Trade Marks Act.
3. The Applicant's Mark consists of an image with little imaginative content. Apart from the main element being a simple rectangle, the individual component of the indented line at the upper centre of the design has no particularly distinctive character which characterizes the image as a whole. The Opponent submits that a simple graphic element such as a rectangle should not be accepted as a trademark as it is rather descriptive;
4. The Applicant's Mark, and shapes or designs similar to the Applicant's Mark, are common to tobacco brands in general, being in particular goods within Class 34 of the International Classification of Goods and Services under the Agreement, of which the Applicant presently seeks registration under (hereinafter referred to as "Tobacco Goods").
5. The Applicant's mark consists of a general design of the particular trade of tobacco goods and quickly conveys the characteristic of such goods related thereto. The characteristics of the Applicant's Mark are intrinsic to the products associated with tobacco goods because of this high descriptive element;
6. A shape such as the Applicant's mark, which is more aptly suited to use as a mere border, does not have a great deal of inherent adaptation to distinguish itself and cannot have become distinctive through use since the design is common to the relevant trade of tobacco goods;
7. The Opponent wishes to draw the attention of the Applicant to the Opponent's prior registration in Belize of certain trade marks under Reg. Nos. 608.02, 609.02, 610.02 and 3427.05 registered on the 5th day of June, 2002, 5th day of June 2002, 5th day of June 2002 and 3rd day of October, 2005 respectively (hereinafter referred to as "the Opponent Marks" and which are attached hereto as Exhibits 1, 2, 3 and 4). As can be plainly seen by a quick study, it would be submitted by even the average consumer, there are the various additions and inclusions of multiple word and design elements which combine to create more than sufficient distinctiveness to each of the Opponent Marks. The Applicant should therefore take guidance in order to supplement the Applicant's Mark with particular distinctive word and/or design elements in order to satisfy the requirements of the Trade Marks Act.
8. The Opponent respectfully requests that the subject application for the Applicant's trade mark be refused registration for the foregoing reasons and more so due to the apparent intention to mislead, craftiness and general mala fides on the part of the Applicant for attempting to register such a basic general design lacking and creativity on the register of intellectual property of Belize.
