## NOTICE OF OPPOSITION

**TAKE NOTICE** that the Registrar is in receipt of a notice of opposition filed by KRAFT FOODS GLOBAL BRANDS LLC, against trademark Application No. 5471.08, filed on the 19<sup>th</sup> day of June, 2008, by ROYAL CHOICE (The Applicant), of Cedar Street, Halls Layout, Corozal Town, Belize, for the registration of the following trademark, as proprietor thereof:



The Opponent opposes the above trademark Application on the grounds that:

1. KRAFT FOODS GLOBAL BRANDS LLC, was first established by its founder, James L. Kraft, on 1903 in Chicago, Illinois, United States of America. Since then, the Opponent has expanded its worldwide operations and today is a leading world-renowned international manufacturing company for food and beverage products. The Opponent has significant business involvement in the discovery, design and development, manufacture, packaging, as well as trade and marketing of various ranges of food and beverage products to consumer markets worldwide. The Opponent has and is continuously achieving immense success in its commercial expansion to be the leader and largest manufacturer and trader of food and beverage products in the world. The Opponent's food and beverage products include famous trademarks such as KRAFT, PHILADELPHIA, OREO, RITZ, CHIPS AHOY!, TANG, MAXWELL HOUSE, MILKA, OSCAR MAYER, PLANTERS, among others.
2. The Opponent has a prior Registration in Belize of the "ROYAL" trade mark under Reg. No. 1317.02 registered on the 7<sup>th</sup> day of January, 2003.
3. Further, the Opponent is the owner of the "ROYAL" trade mark and its extensions and variants in respect of various goods, including but not limited to those protected under International Classes 29, 30, and 32, which are registered in trademark offices around the world. The Opponent's mark "ROYAL" is extremely well-known amongst consumers throughout the world for a long period of time and Opponent has substantial goodwill with the "ROYAL" trademark.
4. The goods of the said application No. 5471.08 are of a similar or related description to the goods protected under the Opponent's trade mark and are likely to deceive or cause confusion.
5. The said trademark which the Applicant has applied to register is so similar to the Opponent's trade mark and as such is likely to deceive and/or cause confusion.
6. By reason of the reputation acquired by the Opponent's trade mark already in use internationally and in Belize mainly in relation to the goods for which it is registered, use of the Applicant's mark sought to be registered would be deceptive and/or confusing and so disentitled to protection in a Court of Justice.
7. The said application No. 5471.08 contravenes section 37(2)(b) of the Trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000 and amendments and should not be registered by virtue of the fact that it is similar to the Opponent's trade mark as earlier trade mark and is to be registered for goods or services identical with or similar to those for which the Opponent's trade mark as earlier trade mark is protected which would cause a likelihood of confusion on the part of the public, which includes the likelihood of association with the Opponent's trade mark as earlier trade mark.
8. On the 9<sup>th</sup> day of November, 2007, a trade mark application numbered 5002.07 (also referred to as the "Previous Application") was filed by one Royal Choice of San Andres, Corozal, Belize (also referred to as the "Previous Applicant") and advertised under the said number 5002.07 in the Gazette (or more particularly the Belize Intellectual Property Journal) of the 14<sup>th</sup> December, 2007, Volume 6, Number 25 the relevant extract of which is attached hereto as Exhibit A.
9. The only apparent difference between the present Applicant and the Previous Applicant is the address relating respectively thereto.

10. The Opponent is led to believe that the Applicant, or persons in control, associated or otherwise connected therewith in one form or the other, had filed the Previous Application which consists of in most part the same mark as the present Application apart from the inclusion of the letter element "e" after the word element "Royal" in the present Application as set out below:

11. The Opponent respectfully requests that the subject application for the Applicant's trade mark be refused registration and due to the apparent intention to mislead, craftiness and general mala fides on the part of the Applicant/Previous Applicant, that any mark or marks associated with the present application, the previous application and any future application be prohibited from the register of trade marks in Belize.







The Applicant is required to submit a response to this notice, to the Registrar, no later than 30 days from the date of publication of this notice.
