**TAKE NOTICE** that the Registrar is in receipt of an answer to opposition filed by Manufacturera 3M S.A. DE C.V., (The Applicant), of Av. Jose B. Lizardi, Zona Industrial, 94640 Cordoba, Veracruz, Mexico, by 3M Company (The Opponent), of St. Paul, Minnesota, United States of America, on the 24<sup>th</sup> day of March, 2006, against trade mark application No. 3538.05, filed on the 29<sup>th</sup> day of November, 2005, by Manufacturera 3M S.A. DE C.V., (The Applicant), for the registration of the following trade mark, as proprietors thereof:



The Applicant hereby gives notice that the following are the grounds on which it relies as supporting the above trademark-

1. the Applicant has actively used its trademark "3M" with grasshopper logo (the "Trademark") in Belize, in relation to goods contained in Classes 7, 11 and 12 in the Nice Classification, 8<sup>th</sup> edition, since on or around 1990, which said goods and services have been supplied to, inter alia, the Belize Cane Farmers Association, Belize Sugar Industries Ltd. and Petrojam Belize Ltd. of various locations of Belize.

Evidence of such use is shown in the attached invoices to said Belize-based parties labeled herein as "Annex 1";

2. the Applicant has already registered its Trademark in Mexico, originally under Mexican Class 23, later reclassified under International Classes 7, 11, 12 (as well as 8, 9, 16, 20 and 21).

Evidence of such registration is shown in the attached Mexican Title of Registration of Mark labeled herein as "Annex 2";

3. Opponent has known about the Applicant's use of the Trademark since the 1960s in Mexico and was unsuccessful in preventing Applicant's use of the Trademark in Mexico and unsuccessful in preventing Applicant's registration of the Trademark in Mexico;
4. on or around 1997, Opponent attempted to buy the Applicant's intellectual property rights through its attorney in Mexico but the Applicant refused to sell its rights to the Trademark to the Opponent. Further, the Applicant has never parted with any of its rights to the Trademark;
5. on or around 1998, Opponent filed an action at the Mexican Institute of Intellectual Property, "Instituto Mexicano de la Propiedad Industrial IMPI", seeking to cancel Applicant's registration in Mexico through a Forfeiture Administrative Affidavit. The Mexican Institute of Intellectual Property denied the Opponent's action on or around 2000.  
  
Evidence of such denial of Opponent's action is shown in the attached Mexican Institute of Intellectual Property Denial of Forfeiture Administrative Affidavit labeled herein as "Annex 3";
6. on or around 2001, Opponent filed an action in the United States District Court for the Southern District of Florida alleging, inter alia, trade mark infringement which case was then settled because the Applicant did not have the resources to facilitate the substantial financial requirements of such an action;
7. the commercial impression of the Applicant's Trademark is entirely different from the Opponent's mark. The grasshopper used as part of the Applicant's Trademark is an image that conveys great value, strength and longevity, which are all commercial connotations carried into the Applicant's business philosophy. The power of a grasshopper's legs translates into the power of the Applicant's machines used in the sugar mills: hydraulic equipment, cranes, semitrailers, backhoes, bronze and gray iron casting. Therefore the use of the grasshopper design should convey to the public that the Applicant adapts to change, survives economic changes, and builds strong equipment that endures through time;
8. there is no overlap or expansion by the Applicant into the Opponents industry or likewise its Trademark - the Applicant sells to sugar mills seeking heavy equipment for use in harvesting and manufacturing sugar. Sales are made on a face-to-face basis. The Applicant sends personnel to the representative locations and offices of sugar plantations to sell the equipment. The Opponent, however, sells to office supply stores and hospitals. These differences make it highly unlikely that vendors and purchasers would confuse merchandise originating from the Applicant and Opponent, which operate in distinctly separate fields and businesses. For this reason, sales of the Applicant's products under the Trademark do not and should not result in any injury to sales of the Opponents products under their trade marks;
9. there is no competent evidence of any actual confusion arising from the public. Parties who wish to purchase products or services from the Opponent in Belize have never contacted the Applicant, and to the Applicant's best knowledge, information and belief the parties who it deals with in Belize are quite certain that their requirements for goods and services are to be provided by the Applicant and not the Opponent;
10. the Opponent by initiating these opposition proceedings is continuing a pattern of harassment of the Applicant, a smaller company, which has its own valid and subsisting rights in the Trademark that do not infringe, dilute or encroach upon the Plaintiff's own rights;

- (3) Before awarding costs in respect of the proceedings, the Registrar must give each party to the proceedings a reasonable opportunity to be heard in relation to the award of costs.

**EXPENSES AND ALLOWANCES**

**Division 1  
Expenses**

1. A person who has paid a fee prescribed by the relevant law in relation to proceedings before the Registrar may be paid the amount of the fee.
2. A person attending proceedings before the Registrar must be paid –
  - (a) a reasonable amount for allowances for transport between the usual place of residence of the person and the place that he or she attends for that purpose; and
  - (b) if the person is required to be absent overnight from his or her usual place of residence - a reasonable amount for allowances up to a daily maximum of \$200 for meals and accommodation.

**Division 2  
Allowances**

3. A person who, because of his or her professional, scientific or other special skill or knowledge, is summoned to appear as a witness before the Registrar must be paid –
  - (a) if the person is remunerated in his or her occupation by wages, salary or fees – an amount equal to the amount of wages, salary or fees not paid to the person because of his or her attendance for that purpose; and
  - (b) in any other case – an amount of not less than \$100, or more than \$500, for each day on which he or she so attends.
4. A person summoned to appear as a witness, other than a witness referred to in paragraph 3, before the Registrar must be paid –
  - (a) if the person is remunerated in his or her occupation by wages, salary or fees – an amount equal to the amount of wages, salary or fees not paid to the person because of his or her attendance for that purpose; and
  - (b) in any other case – an amount of not less than \$60, or more than \$100, for each day on which he or she so attends.
