The Opponent opposes the above Trade Mark Application on the grounds that:

1. Fruit of the Loom, Inc., is the registered proprietor of the FRUIT OF THE LOOM trademark which was registered in Belize on April 7, 1997 under registration number 7697 in class 25;
2. The words "THE LOOM" forms part of the name of registered trademark FRUIT OF THE LOOM;
3. THE LOOM trademark is seeking registration in Classes 24, 25 and 27;
4. Not only is THE LOOM similar in name to the FRUIT OF THE LOOM but it is also seeking registration under Class 25 for which the FRUIT OF THE LOOM trademark is protected;
5. The goods in Classes 24 and 27 are goods which are similar in nature to the goods for which the FRUIT OF THE LOOM trademark is registered and protected;
6. As a result of grounds 2, 3, 4 and 5, there is a likelihood of confusion which may mislead the public into thinking that the trademarks THE LOOM and FRUIT OF THE LOOM are the same or somehow associated;
7. Such confusion may give rise to the "passing off" of THE LOOM trademark for FRUIT OF THE LOOM trade mark and the infringement of FRUIT OF THE LOOM trademark rights pursuant to the Trademarks Act;
8. FRUIT OF THE LOOM trademark has been registered in the United States since August 8, 1871 and in Belize since April 7, 1997;
9. The FRUIT OF THE LOOM trademark was one of the first trademarks to be registered for textiles and is recognized in Belize as the mark of the Fruit of the Loom, Inc. This trademark ranks highly among some of the world's most powerful brands and has gained notoriety and fame both internationally and globally and as such is entitled to protection.

#### ANSWER TO OPPOSITION

**TAKE NOTICE** that the Registrar is in receipt of an answer to opposition filed by GAS TOMZA LTD. (The Applicant), of 7 Craig Street, Belize City, Belize, by Belize Western Energy Limited (The Opponent) of 39 Central American Boulevard, Belize City, Belize, on the 12<sup>th</sup> day of December, 2004, against trade mark application No. 2691.04, filed on the 21<sup>st</sup> day of October, 2004 by GAS TOMZA LTD. (The Applicant) for the registration of the following trade mark, as proprietors thereof:



The Applicant hereby gives notice that the following are the grounds on which it relies as supporting the above trademark-

1. the above mark was never registered in Belize, and we were the first to register it and have the right on a first come first serve basis;
2. the name TROPIGAS is derived from TROPICAL GAS COMPANY INC., with headquarters in Miami, since 1960, which was when the operations were initiated in Central America, Puerto Rico, and the United States of America;
3. the entity TROPIGAS S.A., that before 1980 was engaged in the sale of the line Blanca, furniture, appliances, and LPG, made a separation in the sense that on one part were created the companies TROPIGAS S.A., with headquarters in each country of Central America and were engaged exclusively in the sale of appliances and the line Blanca, and in the case of LPG, on the other part were constituted the entities TROPIGAS DE GUATEMALA S.A., TROPIGAS DE EL SALVADOR S.A., TROPIGAS DE HONDURAS S.A., TROPIGAS DE NICARAGUA S.A., and TROPIGAS DE COSTA RICA S.A., that in individual form operated in Guatemala, Honduras, and Costa Rica, except for TROPIGAS DE EL SALVADOR S.A., and TROPIGAS DE NICARAGUA S.A., that were branches of TROPIGAS DE CENTRO AMERICA;
4. each one of the aforementioned entities remained with the right of the Trade Mark and Logo of TROPIGAS (whose design is what initiated its registration);
5. the entity TROPIGAS DE CENTRO AMERICA, with headquarters in Panama, whose shareholders included Miguel and Eduardo Zaragoza Fuentes, acquired 50% of the shares of TROPIGAS and the remaining 50% passed in the possession of Shell, with headquarters in England;
6. from 1992 Eduardo Zaragoza Fuentes initiated a claim against the shareholders of TROPIGAS (TROPIGAS DE CENTRO AMERICA and Shell), claiming earnings not distributed, and said claim took place in the Republic of Panama, and subsequently at the end of 1994 the Tribunal in Panama resolved in favor of Eduardo Zaragoza Fuentes ordering the intervention of each one of the companies, and in the end of a transaction, the agreement was reached that the shares of TROPIGAS DE GUATEMALA S.A., TROPIGAS DE EL SALVADOR S.A., TROPIGAS DE HONDURAS S.A., and TROPIGAS DE NICARAGUA S.A., pass in the hands of Eduardo Zaragoza Fuentes and TROPIGAS DE COSTA RICA in the hands of Miguel Zaragoza Fuentes, Group Z, obviously with the consent of Shell;
7. on 13 April and 5 May 2000, Eduardo Zaragoza Fuentes, majority shareholder of TROPIGAS DE GUATEMALA S.A., and TROPIGAS DE HONDURAS S.A., transferred his shares to the present shareholders of TROPIGAS DE GUATEMALA S.A. and TROPIGAS DE HONDURAS S.A., and consequently TROPIGAS DE GUATEMALA S.A., and TROPIGAS DE HONDURAS S.A., now form part of GRUPO TOMZA, the parent company of GAS TOMZA LTD.;
8. the above mark continues to be registered in Guatemala and is the exclusive property in Guatemala of TROPIGAS DE GUATEMALA S.A.;
9. the above mark continues to be registered in Honduras and is the exclusive property in Honduras of TROPIGAS DE HONDURAS S.A.;
10. in consequence of the above, it can be inferred that at no time the above mark was sold to Eduardo Zaragoza Fuentes, and neither was it agreed that he would be exclusive owner of the above mark, because it pertains to each company from the moment that they were formed in each country;
11. all the statements made by the Opponent needs to be ratified and proved and demonstrate at what point they obtained the right to use the above mark.




