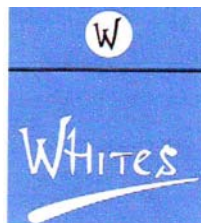

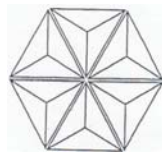

The Opponent opposes the above trademark Application on the grounds that:

- Philip Morris Brands Sàrl (hereinafter referred to as –Philip Morris Brands) is the owner of numerous MARLBORO trademarks. Philip Morris Brands and its affiliates and licensees (collectively –Philip Morris) carry on the business of manufacture, sale and distribution of cigarettes and tobacco products throughout the world. Philip Morris manufactures and sells cigarettes for the global market under various brands including MARLBORO which is one of the most well-known brands worldwide. MARLBORO has been the world’s number one cigarette brand since 1972;

The opponent is the proprietor of more than 50 applications’ registrations in Belize consisting in or containing the word MARLBORO in International Class 34 including but not limited to Marks #976, #6444.09, #3984.06 and #5969.09. The Belizean registration for the word mark MARLBORO dates back to 1954;

- Comparison of goods**

The goods for which the earlier marks are registered in International Class 34 are identical with or similar to the goods for which the contested mark seeks registration in International Class 34;

- Comparison of signs**

The Applicant's mark MALIMBO & Device as depicted above is deceptively similar to the above earlier registrations.

The Applicant's mark consists of the sign MALIMBO written in standard capital letters appearing under a coat of arms with a shield in the middle and two supporters being animals on each side.

In the case of composite marks containing both figurative and verbal elements, it is generally the verbal element which has a greater impression as the consumer more readily refers to, and retains in his mind, marks by their verbal elements. Therefore, the **dominant element** in the Opposed mark is the word **MALIMBO**.

The opponent notably owns a word mark consisting of the sign MARLBORO written in standard capital letters, a stylized mark for MARLBORO as well as word and device marks containing a five-sided figure (Roof Device) in the upper part, right underneath it a coat of arms and the word MARLBORO appearing under said coat of arms.

(i) *Visual similarity*

- If we compare the word elements, the Registered Trademark is eight letters long and the Opposed trademark is seven letters long. The two marks have five of their letters in common, namely, M, A, L, B, and O. Importantly, these 5 shared letters occur in the same order in both marks.

MARLBORO (Registered Trademark)

MALIMBO (Opposed trademark)

The marks are therefore quite similar visually.

- The significant similarity between the word elements of the marks is reinforced by the similarity of their graphic elements and overall architecture: both signs contain a coat of arms centered above the words MALIMBO / MARLBORO. Indeed, the Applicant's mark consists of the sign MALIMBO appearing under a coat of arms with a shield in the middle and two supporters being animals on each side. The Opponent's mark depicted below also contains a coat of arms with two supporters being animals on each side and, immediately below said coat of arms, the word MARLBORO is displayed.



*(ii) Aural similarity*

- The beginning of the marks MARL in MARLBORO and MAL in MALIMBO are almost identical, all the more as either in English or Spanish the letter R in MARLBORO would not be pronounced, i.e. the word MARLBORO would be pronounced /MAL/BO/RO, thus aurally MARLBORO and MALIMBO would be very close. Should the letter R in MARLBORO be anyway pronounced, the signs would still be similar aurally.
- The fact that both marks have an identical or very similar beginning is significant, as the first part of a trademark is generally the part that catches the consumer's attention and is remembered more clearly than the rest of the sign. The beginning of a sign has a significant influence on the general impression given by a Trademark.

4. **Trademarks MALIMBO & Device have been held by Trademark Offices of Spain and Egypt confusingly similar to Philip Morris Brands' MARLBORO Trademarks**

In its Pre-filing Examination Report No. 5746 dated February 2, 2012, the Trademark Office of Egypt held that the trademark MALIMBO & Device was confusingly similar to the trademark MARLBORO & Device in respect of goods in International Class 34.

On 21 January 2010, the Trademark Office of Spain issued a decision according to which the trademark MALIMBO & device was refused registration in respect of goods in International Class 34 for being confusingly similar to the trademark MARLBORO. On 6 April 2010, the Director of the Trademark Office of Spain dismissed the applicant's appeal to this decision and upheld the opposition decision.

Please refer to copies of the aforesaid decisions and their translations for further reference.

5. **Fame of the MARLBORO Trademarks**

The Trademarks MARLBORO of Philip Morris Brands should be considered as well-known internationally and in Belize for tobacco products/cigarettes.

MARLBORO cigarettes were first launched by Philip Morris in 1924 in the U.S. Philip Morris, and/or licensees, have sold MARLBORO cigarettes internationally since at least as early as 1957. The worldwide commercialization of MARLBORO cigarettes expanded at a steady pace through the 1960's, 1970's, 1980's and 1990's, and Philip Morris Brands, its affiliates and/or licensees currently manufacture and/or sell cigarettes bearing the trademark MARLBORO in over 180 countries worldwide. The MARLBORO brand of cigarettes has been internationally protected as a trademark. The well-known status of the MARLBORO word mark has been legally confirmed in several jurisdictions.

Owing to longstanding use, extensive sales and advertising worldwide as an where permitted by law, the MARLBORO brand of cigarettes is among the world's most valuable global brands. In the 2010 BrandZ report, the MARLBORO cigarette brand was ranked number 7. In the 2011 BrandZ report, MARLBORO was ranked number 8.

The MARLBORO brand of cigarettes has been the No. 1 selling brand of cigarettes in the world for at least the past 20 years. The Maxwell Report from 1985 to 2005 shows that MARLBORO is listed as the best-selling cigarette brand in the world – the figures in the chart are worldwide shipments –including the Untied States of America- in million sticks.

In 2010, the sales volume of MARLBORO cigarettes outside the Untied States was 297.4 billion cigarettes. It is larger than its next two competitors combined. Its volume exceeds that of the top four global brands of British American Tobacco.

## 6. Conclusion

The contested goods and services are identical or similar to those for which the earlier marks are registered.

The signs are similar in length, eight letters versus seven letters, and share five letters placed in identical order. They coincide in their first letters (MA) and the letters (LB/BL) and in the final letter (O). Aurally, the marks are very close, all the more as the first R in MARLBORO will not be pronounced either in English or Spanish. Consumers generally tend to focus on the first element of a sign when being confronted with a trade mark. This is justified by the fact that the public reads from left to right, which makes the part placed at the left of the sign (the initial part) the one that first catches the attention of the reader. Furthermore, where a trade mark is composed of verbal and figurative elements, like the Opposed Mark, the former should, in principle, be considered more distinctive than the latter, because the average consumer will more easily refer to the goods and services in question by quoting their name than by describing the figurative element of the trade mark.

In addition, the word MARLBORO is highly distinctive both *per se* and by virtue of intensive use of reputation. It is distinctive *per se* as it does not contain any element descriptive of the goods. The trademarks MARLBORO should be considered as internationally famous due to the extensive use and advertising worldwide as and where permitted by law.

The more distinctive the earlier mark, the greater will be the likelihood of confusion. Furthermore, likelihood of confusion implies some interdependence between the relevant factors, and in particular a similarity between the trademarks and between the goods. Accordingly, a lesser degree of similarity between the goods may be offset by a greater degree of similarity between the marks, and vice versa.

In the case at hand, the goods are identical or similar and the signs are visually and aurally similar and the Trademarks MARLBORO are highly distinctive.

7. Therefore, there exists a likelihood of confusion on the part of the public including the likelihood of association with the earlier marks.
8. such confusion will give rise to the passing off of the goods marketed under the said mark for those of the MARLBORO brand thus misleading the public into the belief that the goods offered by the Applicant are those of the Opponent.
9. The said MARLBORO marks are well known trade marks and as such are entitled to protection under the Paris Convention.
10. The MARLBORO marks have a reputation in Belize and the use of the Applicant's mark without due cause would take unfair advantage of or be detrimental to the distinctive character or repute of the MARLBORO marks.
11. The targeted consumers are the same in that they are persons looking for tobacco products.
12. The channels of trade are identical or substantially similar in that the products are sold where tobacco products are available.

The Applicant is required to submit a response to this notice, to the Registrar, no later than 30 days from the date of publication of this notice.

The Applicant hereby gives notice that the following are the grounds on which it relies as supporting the above trade mark:

1. the mark of the Applicant is not similar to the Opponent's marks;
2. the only common feature between the Applicant's mark and that of the Opponent's marks is the word "ROYAL". Save and except this word, there is no similarity between the Applicant's mark and the Opponent's mark;
3. registration of the RICHMAN ROYAL and RANGE ROYAL trademarks did not, at the time of registration, and does not presently confer on the registered proprietor thereof the exclusive right to the use of the word "ROYAL";
4. The Applicant's mark is easily distinguishable from the Opponent's mark, as the word ROYAL in the Applicant's mark is used to describe a type of flower, namely the ORCHID. The Opponent's marks RICHMAN ROYAL and RANGE ROYAL are not associated with any type of flower;
5. there is no likelihood of confusion between the Applicant's mark and the Opponent's mark which may mislead the public into thinking that the Applicant's mark is associated with the Opponent's marks;
6. the Applicant contends that there is no visual and/or aural similarity through the dominant components of the two marks. The positioning of the word ROYAL in the Applicant's mark further distinguishes it from the Opponent's mark since it appears before the flower that it describes, namely and ORCHID. Conversely, the first words in the Opponent's marks are RICHMAN and RANGE respectively, none of which are in any way associated with or similar to the Applicant's mark.
