5. there is no likelihood of confusion between the Applicant's mark and the Opponent's mark which may mislead the public into thinking that the Applicant's mark is associated with the Opponent's marks;
6. the Applicant contends that there is no visual and/or aural similarity through the dominant components of the two marks. The positioning of the word ROYAL in the Applicant's mark further distinguishes it from the Opponent's mark since it appears before the word SILK, which it describes. Conversely, the first words in the Opponent's marks are RICHMAN and RANGE respectively, none of which are in any way associated with or similar to the Applicant's mark.
