APPOINTMENT OF AGENT

10. (1) An applicant may appoint a person or firm as an agent to act on behalf of the applicant.

(2) Subject to sub-regulation (3), the appointment of an agent need not be made in writing.

(3) The Registrar may, where the circumstances require, request that an agent file a written appointment within a period that the Registrar deems appropriate in the circumstances.

(4) Where an agent fails to file a written appointment as requested pursuant to sub-regulation (3), the Registrar shall give notice to the agent that any further correspondence will be conducted with the applicant until a written appointment is filed.

APPLICATION

11. (1) An application and any amendment to the application shall be Language, etc. in the English language and shall bear the signature of the applicant or the applicant's agent.

(2) A separate application shall be made for each layout-design.

CERTIFICATE OF REGISTRATION

22. (1) The Registrar shall issue a certificate of registration in respect of each layout-design registered under this Act.

(2) A certificate of registration issued in respect of a layout-design shall include the following particulars-

- (a) the name and address of the registered owner of the layout-design;
- (b) the title of the layout-design;
- (c) a description of the nature or function of the layout-design;
- (d) where the layout-design has been commercially exploited, the date on which and place at which the layout-design was first commercially exploited;
- (e) the filing date of the application for registration of the layout-design;
- (f) the date of registration of the layout-design;
- (g) the date of expiration of the exclusive right to the layout-design; and
- (*h*) the registration number of the layout-design.

(3) A certificate of registration issued in respect of layout-design that purports to be signed by the Registrar is, without proof of the signature, admissible in any court as evidence of the facts alleged in the certificate and is, in the absence of evidence to the contrary, proof that -
