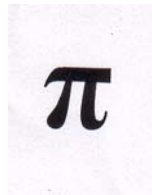

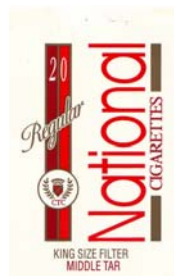

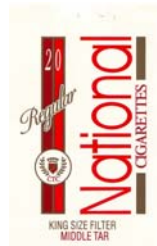

- 14) The company **REPUBLIC TECHNOLOGIES (NA) LLC** respectfully requests BELIPO to refuse the opposition and to allow our trade mark application to proceed to the registration stage by granting the corresponding certificate of registration.
