**TAKE NOTICE** that the Registrar is in receipt of a notice of opposition filed by National Association of Realtors, of 430 North Michigan Avenue, Chicago, Illinois, 60611, United States of America, against Collective Mark Application No. 4473.07, filed on the 20<sup>th</sup> day of February, 2007, by The Association of Real Estate Brokers of Belize (The Applicant), of 2A South Park Street, Belize City, Belize, for the registration of the following collective mark, as proprietor thereof:



The Opponent opposes the above Collective Mark Application on the grounds that:

1. the National Association of Realtors (also referred to as the "Opponent") has been in existence for approximately 100 years. The Opponent was originally founded as the 'National Association of Real Estate Exchanges' on May 12, 1908. In 1916, Charles N. Chadbourne, of Minneapolis, Minnesota, devised the term REALTOR to identify real estate agents who became members of the National Association of REALTORS<sup>®</sup> and subscribed to its strict Code of Ethics. In 1916, the company's name was changed to the "National Association of Real Estate Boards" and in 1974 it became the "National Association of REALTORS<sup>®</sup>".
2. The Opponent became the largest trade association in the United States of America in the early 1970s with over 400,000 members. As of July 31, 2007, the Opponent has over 1.3 million members and over 1400 local associations. In addition, the Opponent currently has 71 international real estate associations in 55 countries. The Opponent adopted a strict Code of Ethics in 1913 and at that time was only the second business group in America to follow the medical, legal and engineering professions in the formation and enforcement of a code for its members.
3. In numerous marketing and promotional materials put out by the Opponent and the Opponent's affiliates worldwide, the materials consistently use the REALTOR marks in a manner consistent with the proprietary nature of the marks. The Opponent's strict Code of Ethics contains specific rules for "use of the REALTOR marks and name." The Opponent issues guidelines, which outline limitations on the use of the REALTOR marks and logo and provide graphic representations of correct and incorrect uses of the logo, in print, in advertisements and on the Internet. The Opponent's web site also lists the "Membership Marks Manual" (see <http://www.realtor.org/letterlw.nsf/pages/trademarkmanual>).
4. The opponent has acquired tremendous reputation in the increasingly competitive real estate market place to become a well-known entity. The Opponent has a broad and longstanding international presence, especially through relationships with real estate agents all over the world. The Opponent's REALTOR word mark has been used in the U.S. since at least as early as 1916. The Opponent owns multiple U.S. registrations for marks that incorporate the term REALTOR, including Reg. No. 519789 for REALTOR (filed July 17, 1947, registered January 10, 1950, claiming use since March 31, 1916) and Reg. No. 515200 for REALTORS (filed July 17, 1947, registered September 13, 1949, claiming use since March 31, 1916). In addition, the Opponent owns multiple applications and registrations for marks that incorporate the term REALTOR around the world (attached hereto as Exhibit A).
5. The Opponent's REALTOR trademark has become well-known and has acquired secondary meaning such that the mere mention of the word REALTOR would immediately conjure in the minds of consumers as that of being goods manufactured and/or services rendered by the Opponent. By virtue of its long, extensive and continuous use, the REALTOR mark has acquired distinctiveness of such a nature that the said mark comes to be inseparably associated with the Opponent and its worldwide associates.
6. The Opponent and its international associates have spent substantial sums to advertise the REALTOR marks. Further, the services of the Opponent, as well as its reputation, have been omnipresent in Belize via Opponent's websites [www.realtors.com](http://www.realtors.com) and [www.realtors.org](http://www.realtors.org), which are both easily accessible to customers in Belize. Therefore, the Opponent's mark REALTOR is extremely well-known to the Belize and global customers including real estate agents also due to their exposure to advertisements in various real estate magazines, journals, etc.

7. In Belize, the REALTOR mark is promoted by Ms. Yvonne Hartshorn. The Applicant has thereby acted in bad faith by filing unauthorized applications for REALTOR and REALTORS in Belize in violation of the opponent’s longstanding worldwide rights and prior rights in the REALTOR marks in Belize.
10. Further, the Applicant is well aware of the Opponent’s prior rights in the REALTOR marks given that Applicant’s previous trademark applications in Belize, App. No. 2/00004094 for REALTOR filed September 20, 2006 in Class 36 and App. No. 2/00004095 for REALTORS filed September 20, 2006 in Class 36, were successfully opposed through the efforts of the Opponent’s local affiliate, Ms. Yvonne Hartshorn.
11. **TAKE NOTICE** that the Registrar is in receipt of a notice of opposition filed by National Association of Realtors, of 430 North Michigan Avenue, Chicago, Illinois, 60611, United States of America, against Trade Mark Application No. 4474.07, filed on the 20<sup>th</sup> day of February, 2007, by Real Estate Brokers of Belize (The Applicant), of 2A South Park Street, Belize City, Belize, for the registration of the following collective mark, as proprietor thereof:



The Opponent opposes the above Collective Mark Application on the grounds that:






1. the National Association of Realtors (also referred to as the “Opponent”) has been in existence for approximately 100 years. The Opponent was originally founded as the ‘National Association of Real Estate Exchanges’ on May 12, 1908. In 1916, Charles N. Chadbourne, of Minneapolis, Minnesota, devised the term REALTOR to identify real estate agents who became members of the National Association of REALTORS<sup>®</sup> and subscribed to its strict Code of Ethics. In 1916, the company’s name was changed to the “National Association of Real Estate Boards” and in 1974 it became the “National Association of REALTORS<sup>®</sup>”.
2. The Opponent became the largest trade association in the United States of America in the early 1970s with over 400,000 members. As of July 31, 2007, the Opponent has over 1.3 million members and over 1400 local associations. In addition, the Opponent currently has 71 international real estate associations in 55 countries. The Opponent adopted a strict Code of Ethics in




1913 and at that time was only the second business group in America to follow the medical, legal and engineering professions in the formation and enforcement of a code for its members.

3. In numerous marketing and promotional materials put out by the Opponent and the Opponent's affiliates worldwide, the materials consistently use the REALTOR marks in a manner consistent with the proprietary nature of the marks. The Opponent's strict Code of Ethics contains specific rules for "use of the REALTOR marks and name." The Opponent issues guidelines, which outline limitations on the use of the REALTOR marks and logo and provide graphic representations of correct and incorrect uses of the logo, in print, in advertisements and on the Internet. The Opponent's web site also lists the "Membership Marks Manual" (see <http://www.realtor.org/letterlw.nsf/pages/trademarkmanual>).
4. The opponent has acquired tremendous reputation in the increasingly competitive real estate market place to become a well-known entity. The Opponent has a broad and longstanding international presence, especially through relationships with real estate agents all over the world. The Opponent's REALTOR word mark has been used in the U.S. since at least as early as 1916. The Opponent owns multiple U.S. registrations for marks that incorporate the term REALTOR, including Reg. No. 519789 for REALTOR (filed July 17, 1947, registered January 10, 1950, claiming use since March 31, 1916) and Reg. No. 515200 for REALTORS (filed July 17, 1947, registered September 13, 1949, claiming use since March 31, 1916). In addition, the Opponent owns multiple applications and registrations for marks that incorporate the term REALTOR around the world (attached hereto as Exhibit A).
5. The Opponent's REALTOR trademark has become well-known and has acquired secondary meaning such that the mere mention of the word REALTOR would immediately conjure in the minds of consumers as that of being goods manufactured and/or services rendered by the Opponent. By virtue of its long, extensive and continuous use, the REALTOR mark has acquired distinctiveness of such a nature that the said mark comes to be inseparably associated with the Opponent and its worldwide associates.
6. The Opponent and its international associates have spent substantial sums to advertise the REALTOR marks. Further, the services of the Opponent, as well as its reputation, have been omnipresent in Belize via Opponent's websites [www.realtors.com](http://www.realtors.com) and [www.realtors.org](http://www.realtors.org), which are both easily accessible to customers in Belize. Therefore, the Opponent's mark REALTOR is extremely well-known to the Belize and global customers including real estate agents also due to their exposure to advertisements in various real estate magazines, journals, etc.
7. In Belize, the REALTOR mark is promoted by Ms. Yvonne Hartshorn. 

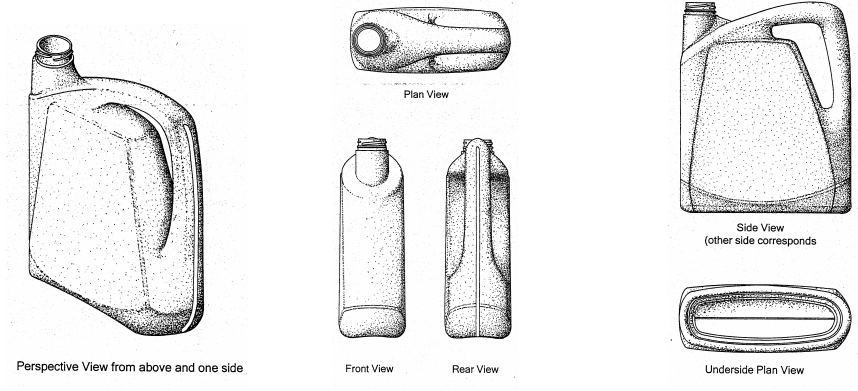
