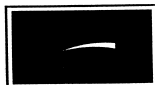

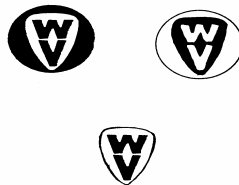

2. The said VITAMALT mark was so registered under Registration No. 6623 in Class 32 of the Nice Classification in respect of non-alcoholic drinks and preparations for making drinks, all included in Class 32 and containing malt extract and/or malt flavoring.
3. The word "VITA" forms part of the name of the registered trademark VITAMALT.
4. The VITA mark is identical with or similar to the VITAMALT mark, which is an earlier trade mark.
5. The VITA trademark is seeking registration in Classes 29, 30 and 32 and the VITAMALT trademark is protected under Class 32;
