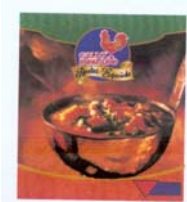

To date Mr. Eduardo Zaragoza is still the owner/majority shareholder of TROPIGAS DE EL SALVADOR and TROPIGAS DE NICARAGUA as well as BELIZE WESTERN ENERGY LIMITED, which is a company incorporated in Belize with its principal place of business located at 39 Central American Boulevard, Belize City, Belize (hereinafter referred to as BWEL);
5. BWEL is engaged in the sale of butane gas to the public and has been doing business in Belize since its date of incorporation in 1987 and has, with the consent of Mr. Zaragoza, been exclusively using the Tropigas name and logo since 1994;
6. Additionally there are two International Business Companies incorporated under the laws of Belize namely Tropigas Trading and Tropigas Transport which are owned by Mr. Eduardo Zaragoza;
